

Privacy Policy

The following privacy policy explains the purpose of collection and use of your personal information by our website and application, **applications** and by third parties. It's solely and only applied to the "Who is Happy" website and application and applications hosted on the <http://www.whoishappy.com> and other domains. Who is Happy agrees to act in compliance with the current legislation and adopt the best practices on the Internet. 1. Login and registration of personal information

You are going to have to submit personal information (name, email address, among others) in order to receive or use the services from this website and application. By entering your data on the specific fields, you authorize the website and application to register your personal information in order to provide you the service required. We will treat such personal information in compliance with this privacy policy.

In order to have access to all the Who is Happy features, you must register to create an account ("Account") and become a Member.

You may register directly by logging into your account with certain Social Networking Services via the Site, as described herein. During the registration process, you will be required to provide certain information. We will extract certain personal information you have provided to the SOCIAL NETWORKING SERVICE, certain other information you make publicly available via the SOCIAL NETWORKING SERVICE from the account you have with the applicable SOCIAL NETWORKING SERVICE and use that information to create your Account. The specific information that we extract may depend on the privacy settings you and your SOCIAL NETWORKING SERVICE friends have with the SOCIAL NETWORKING SERVICE. For certain Social Networking Services through which you may choose to register, a pop-up box may appear as part of the Account registration process which you will need to approve in order to proceed, and which will describe the types of personal information that we will obtain from, and the types of activities that we or you may perform in connection with, your account on such SOCIAL NETWORKING SERVICE. You hereby consent to our access to and collection of personal information about you that we obtain from the applicable SOCIAL NETWORKING SERVICE, which access and use shall be in accordance to this document. In addition, you hereby agree that we may continue to access and use such personal information in accordance with the Privacy Policy in the event the Who is Happy Services no longer use the SOCIAL NETWORKING SERVICE platform

through which we obtained such information or if your Who is Happy Account otherwise ceases to be linked to your SOCIAL NETWORKING SERVICE account.

You agree to provide accurate, current and complete information during the registration process and to update such information to keep it accurate, current and complete. We reserve the right to suspend or terminate your Account if any information provided during the registration process or thereafter proves to be inaccurate, not current or incomplete. You are responsible for safeguarding your SOCIAL NETWORKING SERVICE, Account. You agree that you will not disclose your password to any third party and that you will take sole responsibility for any activities or actions under your Account, whether or not you have authorized such activities or actions. You will immediately notify Who is Happy of any unauthorized use of your Account.

2. Information about visitors

In any visit to our website and application, several files will be copied by your computer, including texts, videos and pictures from the pages you access besides the files that help us recognize specific visitors (e.g. cookies). Such files enable us to perform useful tasks for you, such as offering a customized service and analyze the profile of our visitors in order to improve the website and application. You can block some of these files from your computer. The data that we collect about our visitors are used in accordance with this privacy policy.

3. Identification of visitors and access to the website and application

Although the website and application doesn't automatically recognize each user, only the computers used, the full access to the website and application depends on a personal and non-transferable password, provided to each one of our users. We do that in order to ensure that our website and application is accessed by users that are able to collaborate in a healthy way with the democratic debate, as well as provide customized services and monitor the traffic of visitors in our website and application. If you wish so, you can block some of the files used for the automatic recognition of your computer (e.g. cookies), but in any access to our website and application, you need to provide your personal and non-transferable password; by doing it, our customized services will be at your disposal, and you are going to be personally recognized by our website and application.

4. Submission of personal information

Our website and application receives personal information from visitors on a daily basis. We collect these pieces of information in a transparent way, in compliance with this privacy policy, and we ask such information in order to (i) enable your access to the website and application, which is subject to the registration, and (ii) improve our website and application and the services provided. Our website and application commits to inform you about how your information is used by means of this privacy policy, which might be changed in the future. By entering our website and application, you must check if you agree with our privacy policy. Our website and application stores your personal information in our system only for the time necessary to make sure that the services we provide can be offered normally. Your personal information is stored in a safe way.

5. Access to personal information

You have the right to ask for a copy of your personal information, stored in our website and application, and have the right to ask for corrections in case some data is inaccurate.
